INVITED PLAYERS:

The invited players are the Top 4 in the COTECC U14 ranking up to August 10th, 2026. 4 additional players will be selected who comply with the following criteria:

1. Winner JITIC U14 G1+
2. Finalist JITIC U14 G1+
3. Player with ITF ranking of 1700 or better
4. Second player with ITF ranking of 1700 or better
5. Of the COTECC teams that participated in the Final Qualifying WJTC, the player who plays as #1 in the team and has the best results in the event
6. Of the COTECC teams that participated in the Final Qualifying WJTC, the player who plays as #2 in the team and has the best results in the event

Any vacancies will be filled based on the COTECC U14 ranking up to August 10th, 2026.

Players finishing in the top 4 places in each category in the COTECC MASTER U14 will be invited to the GSPDP COTECC U14 team that will participate in the ITF Junior tournaments in El Salvador and Guatemala, to be held in October and November. Additionally, this team will compete in the America's Cup U14 2026 to be held in Orlando, Florida following the tour. If any of these 4 players, after the end of the Masters, are unable to participate with the teams, they will be replaced by the player who ended in 5th place, and so on.

The winners (boy and girl) will also be invited to the **GSPDP ITF 14&U International Touring Team to Florida 2026.**

If a player is unwilling or unable to participate as a member of the GSPDP COTECC U14 team to the ITF Junior tournaments in El Salvador and Guatemala or with the GSPDP ITF International 14&U Touring Team to Florida 2026, we would appreciate they decline on the acceptance form.

It's important that players have a valid US visa in order to be a member of the COTECC team that will participate in the America's Cup and/or the GSPDP ITF 14&U International Touring Team to Florida 2026. In case the player does not have a valid visa, we suggest he/she gets one as soon as possible in order to avoid last minute setbacks.

HOSPITALITY

Players and coaches will stay at the Holiday Inn Villahermosa.

Full hospitality will be provided for players beginning with dinner on Saturday, Sept. 5th and ending with breakfast on Saturday, Sept. 12th. Players who arrive before dinner on Sept. 5th or leave after breakfast on Sept. 12th will be responsible for any additional costs. Full hospitality will be given to 1 coach per participating nation.

The nation that participates with more than 4 players can send 2 coaches, who will be given full hospitality. Players and coaches will stay in double rooms.

The travelling coach must be endorsed by the National Federation of the nation their player(s) is representing and must have minimum an ITF Level 1 certification.

TRAVEL ARRANGEMENTS

COTECC will pay the plane tickets for the players travelling to Tabasco, Mexico.

TRANSPORTATION

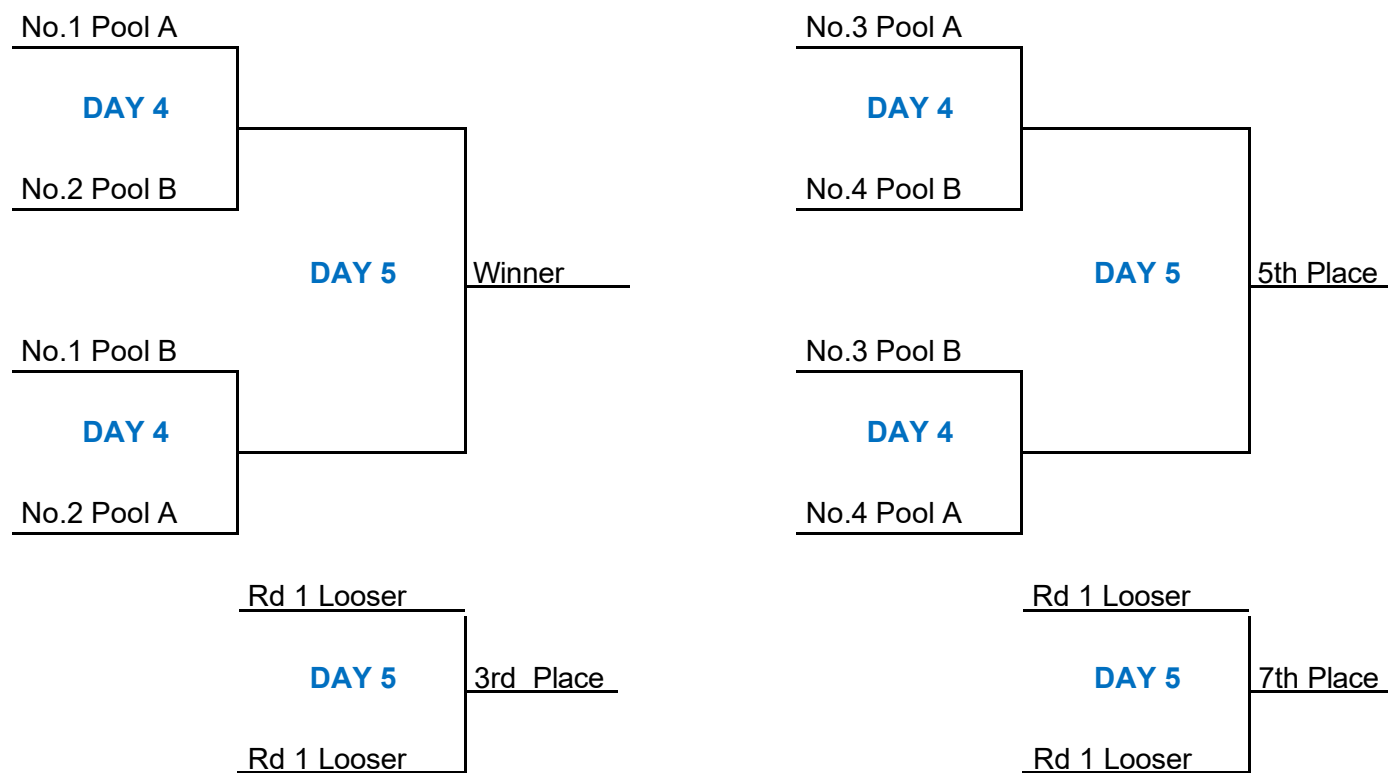
Transportation will be provided by the organizer to and from the airport and if needed, from the hotel to the courts.

FORMAT OF PLAY:

Singles: 2 of 3 sets, all with tie break and advantage

Singles First phase: 2 Round Robin of 4 players

Singles second phase: the order in which players qualify for the second phase (draws) will be based on the current COTECC U14 Circuit regulations and in the following format:



Doubles: 2 sets to 6 games, no ad. In case of a tie to one set each, a match tiebreak to 10 points will be played to decide the winner.

Round Robin of 4 teams. Players chose their doubles partner. Seeds are chosen based on the combined current ranking for both players. Ties are decided based on the COTECC U14 Circuit regulations.

Mixed Doubles: 1 draw of 8 teams. Single elimination.

Seeds will be decided according to the singles results of the players, after the RR, which takes into account the percentages of matches, sets and games played and won.

The positions of the 2 team members will be added and the players that have the highest sum will be seeded 1 and 2 in the draw. If there is a tie in the sum, the seed will be drawn by lot.

System to define places at the end of the competition:

Points will be awarded during the competition in order to define the 8 positions in boys and girls.

Each event in which the player participates will be awarded points according to the position they reach:

CODE OF CONDUCT

The 2026 ITF WTT Junior Circuit Code of Conduct will be applied.

WAIVER OF CLAIMS

All players participating in ITF Junior Circuits accept, as a condition for their participation, not to press charges against the ITF, COTECC, the tournament organizers, and national federations, regarding injuries (regardless of their cause) or loss of personal property during the COTECC Junior Circuit tournaments or when going back and forth to the tournaments. **For this reason, it is mandatory for all players and coaches to have a proper medical insurance with international coverage which includes coverage for COVID-19, and which cannot be given by the ITF, COTECC, the national federation hosting the event nor the local organizer.** The ITF, COTECC, National Federation hosting the event, local organizer will not be responsible for providing any medical insurance nor paying for any medical bills for any player/coach.
